**STUNNING SCOTTISH GOLF RESORT JOINS *THE REGISTRY*

Hammersmith, London (July 7, 2010) – Southworth Development LLC today announced the affiliation of its new golf resort, The Village at Machrihanish Dunes, to *The Registry Collection* program, the world's largest luxury exchange program and one of the Wyndham Worldwide family of brands under the RCI umbrella (NYSE: WYN).

For guests more interested in holiday pursuits off the fairways, the development offers many attractions, including a beach, biking and walking trails, wind surfing, fishing, a wildlife reserve and observatory.

The Village at Machrihanish Dunes also features the newly renovated Old Clubhouse Pub, serving a full range of bar food and fine dining options, with a gym and spa due to open in 2011. The exclusive leisure property offers high-level service to its guests, who can call on concierge and room services, as well as airport transfers. Future phases of development include restoration of two classic Scottish hotels and the creation of residential family properties.

Fractional properties at the resort will be cottages to be sold by the developers in four-week fractional use periods (one in each season) with prices ranging from £46,000 to £69,700, depending on the size and location of the cottage. The developers are also extending to qualified purchasers the chance to buy a Discovery Package, which offers two nights' accommodation and golf for £139.

Complementing the golf lifestyle, fractional owners are entitled to free use of the golf course during their weeks of occupancy (green fees are usually £95 per day). Two years' membership of *The Registry Collection* program is also included in the purchase price at this development.

Affiliation to *The Registry Collection* program adds a further benefit, with more than 175 properties available through the program that are either accessible for exchange or under development. Other membership benefits include concierge services and access to luxury travel partner products.
